

## **Information for Institute Level Counselling Round (ACAP) for F.Y.B.Tech. Admission 2022-23**

Institute Level Counselling Round (ACAP) against vacant seats at WCE after CAP-III will be carried out as per the inter-se-merit.

- 1. Candidates (who have applied to the Competent Authority for verification of document & received confirmed application Id number) have to submit Google Form (Link available in page no. 3, schedule) for Institute Level Counselling Round (ACAP) on or before 19/11/2022 up to 11.59 pm. And also submit duly filled application form in prescribed format along with receipt of processing fee (Rs.800/-) and with required attachment to WCE by hand on 20/11/2022 between 9.00 am to 11.30 am.**
- 2. The candidates who submit online Google Application form with processing fee for Institute Level Counselling Round (ACAP) and submitted hard copy as per deadline will only be considered for Institute Level Counselling Rounds admission process. (Candidate having Receipt of CVC/NCL/EWS are eligible within respective category only after producing fresh Acknowledgement issued by concern FC having information of uploaded required document.)**
- 3. The application-processing fee for Institute Level Counselling Round (ACAP) is Rs. 800/- (INR Eight hundred only) (Non-refundable). The Candidates have to pay this fee through online mode only by scanning following QR code**

- 1.The amount of fees should be paid through online mode NEFT/RTGS/GOOGLE PAY / PHONE PAY / CARD PAYMENT OR D.D. in the name of “Director Walchand college of Engineering, Sangli” payable at Sangli
  2. The candidates already admitted in Walchand College of Engg. Sangli through CAP-I, CAP-II & CAP-III have to pay the difference fee for the Freeship/EBC/TFWS/EWS and cancellation charges Rs.1000/- in the form of DD/ online mode.

7. Candidate will lose claim to participate in the admission counselling process, if he/she fails to produce ALL the applicable original documents at the time of document verification during counselling round.

8. In case a candidate has taken admission elsewhere, he/she will be required to submit/produce original Admission letter issued from CET cell portal and the candidate should submit undertaking stating that original documents will be submitted by him/her within **four working days** from the date of reporting/ admission.
9. Vacancy shall be filled in by the candidate from the same category for which it was earmarked during the CAP. Further if the seats remain vacant then the seat shall be filled on the Inter-Se-Merit of the applicant.

**13. Admissions in Institutional Quota and vacant seats after CAP.-** The Director or Principal of the institution shall carry out the admissions for these seats in the following manner. -

- (a) Admissions shall be made in a transparent manner and strictly as per the *Inter-Se-Merit* of the Candidates who have applied to the Competent Authority for verification of documents and then to the Institution.
- (b) Information brochure or prospectus of the Institution which specifies rules of admission should be published well before the commencement of the process of admission. All the information in the brochures should also be displayed on the Institution's website.
- (c) Institution shall invite applications by notifying schedule of admission and the number of seats in each course to be filled by the institution, by advertisement on the website of the institution.
- (d) Aspiring Candidates fulfilling the eligibility criteria as notified by the Government and specified by the appropriate authority, from time to time, shall apply to the Principal or Director of the respective institution for admission at the Institution level as provided in rule 3(4)(b) and shall be filled in on the basis of Inter-Se-Merit prepared by following the procedure specified in 8(3).
- (e) The institution after verification of all required documents shall prepare and display the Inter-Se-merit lists of the Candidates to be filled in at the institution level, in the Institutional Quota and Supernumerary Quota of OCI / PIO, Foreign National, Children's of Indian workers in Gulf Countries along with the vacant seats after CAP, on the notice board and shall publish the same on the website of the institution.
- (f) The Minority or Non-Minority institution intending to surrender the Institutional Quota (in part or full) of specified courses to the CAP shall communicate two days before the display of seat matrix of CAP Round I and the same shall be allotted as per the rules of CAP. The Institutes shall not be allowed to surrender Institutional quota seats thereafter.
- (g) All the admissions and cancellations shall be updated instantly through online system.
- (h) If any CAP seat remains or becomes vacant after the CAP Rounds, then the same shall be filled in by the Candidate from the same Category for which it was earmarked during the CAP. Further if the seats remain vacant then the seats shall be filled on the basis of Inter-Se-Merit of the applicants.
- (i) While filling these seats the preference shall be given to Maharashtra State Candidature Candidate over All India Candidature Candidate on the basis of Inter-Se-Merit.
- (j) After exhausting Maharashtra State Candidature Candidate and All India Candidature Candidate, if any seat remain vacant in the Sanctioned Intake then these seats may be filled with NRI, Foreign Students (FS), Overseas Citizen of India (OCI), Persons of Indian Origin (PIO), Children of Indian Workers in the Gulf Countries (CIWGC) Candidature Candidates, if the institute has secured prior approval from appropriate authority for these seats.

11. Candidates have to be present in the WCE Counselling centre (Tilak hall) and wait for their turn as per inter-se merit. If a candidate is found unavailable when called, the next candidate on the merit rank shall be called for allotment of seat and the unavailable candidate may miss his/her chance of merit based seat allotment.

12. If a candidate of higher WCE institute round merit reports late during the process of counselling, the candidate may be considered for allotment of a seat available at that point of time for a particular category to which he/she belongs. Such a candidate shall be given preference for admission over the candidates with lower rank present at that point of time. The decision of the Chairman UG admission committee shall be final and binding to all.
13. Part, cheque and cash payment will not be accepted under any circumstances.
14. After allotment of seat, candidate will be issued an allotment letter duly signed by the Admission Authority.
15. Every candidate has to submit one set of xerox copies of certificates / documents uploaded during application to CET cell and acknowledgement of application.
