Your sealed envelope should contain all the pages 1 to 7, needed to fulfill the terms and conditions, **tender properly filled with the competitive price offered, duly signed and stamp sealed on each page otherwise it is liable for rejection.** This sealed envelope should also contain earnest money deposit of Rs. 4000.00 (In words Rs. Four thousand only) in the form of bank D.D. favoring Director, Walchand College of engineering, Sangli payable at Sangli.

The place of delivery is old library of college and period of completion of offer is 21 days from the date of work order.

Please note that the last date for submission of Tender is 9th January 2017 up to 12:30 p.m. and will be opened on 9th January 2017 at 03:30 p.m. at Conference hall, Walchand College of engineering, Sangli.

Terms and Conditions:

1. The bidder shall provide qualification information, which shall include: -

- (a) Total monetary value of work performed for each year of the last 3 years, which exceed estimated cost of present work.
- (b) Income tax clearance certificate from the concerned IT circle;
- (c) Report on his financial standing.
- (d) Details of any litigation, current or during the last 3 years in which the bidder is involved, the parties concerned and disputed amount in each case
- (e) Bidder shall not assign or sublet the contract to any other sub-vendor.

2. Bid Price

- a) The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initializing, dating and re writing in words.
- b) **All duties, taxes, Octroi, VAT and other levies etc. as applicable are payable by the bidder under the contract and shall be included in the total price.**
- c) The rates quoted by the Bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d) The prices should be quoted in Indian Rupees only.

3 Each Bidder shall submit only one Tender.

4 Validity of Tender

Tender shall remain valid for 30 days after the deadline date specified for submission.

5 Evaluation of Tenders

The Owner will evaluate and compare the Tenders determined to be substantially responsive i.e. which

- (a) Receipt of tender form fee or DD of Rs 1000/- towards cost of tender form in case of Downloaded form.
- (b) Conform to the terms and conditions, and specifications
- (c) Evaluation and Comparison of bids shall be done on Total price including charges like transportation, freight and insurance, commissioning, VAT, Octroi any other installation/fixing etc.
- (d) **Any conditional Tender will not be accepted and quantity of the items may vary as per requirement at the time of work order.**
- (e) Earnest money deposit of Rs. 4000.00 (In words Rs. Four thousand only) in the form of bank DD. favoring Director, Walchand College of engineering, Sangli payable at Sangli.

7 Award of contract

The Owner will award the contract to the Bidder whose Tender has been determined to be substantially responsive as per the terms and conditions.

8 A) Notwithstanding the above, the Owner reserves the right to accept or reject any Tenders and/or to cancel the bidding process and/or reject all Tenders at any time prior to the award of contract.

B) The Bidder whose bid is accepted will be notified of the award of contract by the Owner prior to expiration of the Tender validity period. The terms of the accepted offer shall be incorporated in the work order. Bidder shall ensure its completion within the contract period.

9 **The duration of work is 21 days from the date of Work order. The penalty for delay in proportion to the cost of work usually at rate of 1% for first 10 days, 2% for next 10 days shall be charged. In case of delay, more than 20 days, order shall automatically stand**



cancelled. After the work is complete the contractor shall inform the engineer incharge and the engineer incharge will issue work completion certificate if he found satisfactory completion of work.

- 10 Payment will be made after issue of completion certificate by the engineer to the contractor and subsequent bill is submitted by the contractor:
95% against satisfactory completion of the work. Remaining 5% as “Performance Security” at the end of warranty period or on submission of the Bank Guarantee and undertaking for the said amount.
- 11 Normal commercial warranty/ guarantee shall be applicable to the work as follows.
 For 12 months from date of satisfactory completion of work.
- 12 In case of dispute, persons appointed by WCE will act as Conciliator. All legal disputes are subject to the Jurisdiction of Sangli court only.
- 13 **Rights to change quantity, any clause fully or partially in the terms and conditions mentioned above and right to cancel any Tender without giving any reason is reserved with Director, Walchand College of Engineering, Sangli.**
