Item No. 3. <u>To consider appointment of Prof. P.J. Kulkarni as Professor in CSE and Head of PG Section</u>

Prof. P.J. Kulkarni, Professor in CSE and Deputy Director, superannuated on 31 December 2017 after working for nearly three decades with WCE. Considering his considerable academic and administrative experience, the Director submitted a proposal for appointing Dr P.J. Kulkarni as Professor in CSE and utilizing his vast expertise for the benefit of students and the institute. He also proposed that Dr. P.J. Kulkarni be given additional responsibility to function as Head of PG section so as give focused attention to PG section and promote research, development and consultancy activities.

It was proposed to pay Prof. J. Kulkarni an additional allowance of Rs. 20,000 per month for functioning as Head of PG section, subject to his pay on re-employment plus pension not to exceed the substantive pay drawn before retirement, as per MCSR (Pension) Rules-1982. It was then

Resolved that appointment Prof. P.J. Kulkarni, as Professor in CSE and Head of PG Section with additional allowance as proposed is approved.

Item No. 4. <u>To consider change in nomenclature of PG programs align these with the AICTE</u>

The difference in the nomenclature used for a few PG programs at Shivaji University, DTE and AICTE Level was observed during the accreditation of PG programs. It is, therefore, proposed to change nomenclature of the PG programs to align these with the nomenclature as given in the AICTE Handbook. The comparative details and proposed changes were presented to the members. The IQAC Coordinator reported that these changes were already informed to Shivaji University and DTE, Maharashtra State for obtaining NOC from them Alter discussions, the members,
